Co-construction in the euro-med Region for youth Employment: an Action between Territories and the Economic world (CREATE)

- The project answers the ENI CBC MED call for proposals:
€ 84.6 million for the financing of cross-border cooperation projects in the Mediterranean
- With the priority A.3.1 (€ 8.47 million):
Provide young people, especially those belonging to the NEETS, and women, with marketable skills

Context

- The issue of youth unemployment often comes from a lack of communication between territories and the economic world. Dynamic companies are willing to recruit, but do not find the workforce with adequate training; territories do not necessarily have the information to provide with the optimal education offer; and young graduates are eager to complete their education with new exploitable skills.
- The HOMERe project (a European Union funded program, labelled by the Union for the Mediterranean) has been facilitating the connection between companies and territories since 2015. Thanks to its large network of academic and professional institutions, it offered internships to numerous young graduates in the Mediterranean, giving them new marketable skills.

Proposal

- This project follows on from the HOMERe's successes ; it focuses on education, and proposes to look first at the companies' needs.
- It will thus aim at identifying these needs in terms of workforce to offer short-term training courses to unemployed youth and fresh graduates.
- The project will allow the consortium to set up these courses with the outcome that the newly trained young people will be recruited by the companies that are concerned.
- As a regional project, it will implement the same global strategy in all territories.

Partnership

The Euromed Cities Network (represented by the city of Nice) will be the project leader and will capitalise on the experience of the HOMERe project.
