For four years, from 2012 to 2016, he served on Jordan's Accreditation and Quality Assurance of Higher Education Institutions Council. During this time, he also chaired several quality assurance committees in higher education institutions.

Dr. Alshibly research interests include electronic human resource systems, customer empowerment, e-commerce, e-government, e-marketing, decision support systems, and evaluating and deploying electronic document management systems. He has published over 50 academic works, including books, book chapters, journal articles, and conference papers.
